### PUPPY SALES CONTRACT

The Seller, \_\_\_\_\_, and the Buyer, \_\_\_\_\_, hereby agree as follows:

1. The Seller hereby sells to the Buyer, AKC registered Pure Bred, \_\_\_\_\_  
Puppy known as \_\_\_\_\_ for the amount of \$ \_\_\_\_\_, payment of which is hereby  
acknowledged, a male/female puppy, born \_\_\_\_\_, by

of this contract.

Buyer to pay non-refundable deposit of \_\_\_\_\_ to hold (puppy # \_\_\_\_\_)  
Male \_\_\_/Female \_\_\_ with the balance of \_\_\_\_\_ due at pickup time or if shipping,  
balance plus shipping must be paid in full before puppy ships to buyer.

2. The Seller will provide registration papers to the Buyer. Seller gives limited \_\_\_\_\_ / full \_\_\_\_\_  
registration.

3. The Seller guarantees that the puppy is in good health on the date of delivery. The Buyer is  
encouraged to see your Vet for a wellness checkup within **72 hrs**. If life threatening illness is  
found, Seller will replace puppy with a new puppy of equal value. Buyer must provide written Vet  
statement to seller in order to receive replacement puppy. At no time will a cash refund be given.  
Upon shipping the seller is required to provide a veterinarian certificate of good health. This vet  
examination must be within 10 days of shipping. We consider this certification to be proof that the  
puppy is free of any disease or illness at time of sale. We can not guarantee any sickness due to  
stress related conditions due to shipping or movement to a new home. We do not guarantee  
against, Kennel cough, Low Blood Sugar (Hypoglycemia), ear mites, worms, coccidia, or fleas or  
ticks. These issues are treated by us on a regular basis. If exchange or replacement puppy is  
needed the Buyer will be responsible for shipping/return costs to the Seller.

4. The Seller guarantees that the puppy is free of hereditary defects to the best of his/her  
knowledge. The Buyer will receive a replacement puppy of equal or greater value from our next  
available litter if this puppy has any congenital defects which result in death or in its having to be  
euthanized **within three years** of this sale. At no time will a refund of cash money be given. Seller  
must be provided with a written report of the dog's health problem from Buyer's veterinarian. The  
Buyer assumes full responsibility of costs and care during this time.

5. The Buyer shall maintain the puppy in good condition, including adherence to a regular  
immunization schedule, heartworm preventative, good diet, and a clean and safe environment. If

at any time the buyer is unable to care for the puppy it is to be returned to seller. No refund will be given.

6. If at any time in its life the puppy is to be sold or given away, the Buyer shall so notify the Seller and give the Seller first option to obtain the puppy back.

7. The Buyer has read and understands the foregoing and agrees that all parts and portions therefore constitute a binding agreement. This contract constitutes the entire agreement of the parties hereto with respect to sale herein. Buyer assumes responsibility of this contract and agrees to pay any court fees if buyer fails to live up to the agreements listed in this contract.

8. If puppy purchased before 8 weeks, Buyer agrees to pick-up or Seller to arrange shipping by 8 weeks of age. If buyer unable to take puppy at that time there will be a boarding fee of \$10.00 per day for a maximum of 2 weeks after which time the seller will put puppy back up for sale.

Thank you and always remember if you give this puppy/adult all the love, attention and guidance you can, this puppy/adult will in turn do the same for you. Take care of your precious baby.
