follows:

1. The Seller hereby sells to the Buyer, AKC registered Pure Breed _____
known as color _____ for the amount of _____ a puppy, born by
_____, out of _____, in accordance with the terms of this contract.

Buyer has paid a non-refundable deposit of _____ with the balance

of _____ due at pickup time or if shipping, balance plus shipping must be

paid in full before puppy ships to buyer.

The Seller will provide registration papers to the Buyer. Seller gives limited _____ / full _____ registration. The Seller guarantees that the

puppy is in good health on the date of delivery. The Buyer is encouraged to see your Vet for a wellness checkup within **72 hours**. If a life-threatening illness is found, Seller will replace the puppy with a new puppy of equal value. Buyer must provide a written Vet statement to the seller in order to receive a replacement puppy. At no time will a cash refund be given. Upon shipping the seller is required to provide a veterinarian certificate of good health. This vet examination must be within 10 days of shipping. We consider this certification to be proof that the puppy is free of any disease or illness at time of sale. We cannot guarantee any sickness due to stress related conditions due to shipping or movement to a new home. We do not guarantee against kennel cough, low blood sugar (Hypoglycemia), ear mites, worms, coccidia, giardia or fleas or ticks. These issues are treated by Rising Star Kennels on a regular basis. If an exchange or replacement puppy is needed the Buyer will be responsible for shipping/return costs to the Seller.

2. The Seller guarantees that the puppy is free of hereditary defects to the best of his/her knowledge. The Buyer will receive a replacement puppy of equal or greater value from our next available litter if this puppy has any congenital defects which result in death or in it having to be euthanized **within two years** of this sale. As a quality breeder, our highest priority is the health of the dogs we breed. Part of that responsibility includes doing everything possible to assure their wellbeing after they go to a new home. While all quality dog foods will provide everything needed to sustain life, virtually all of them are cooked during the manufacturing process. The heat from cooking causes much of the nutrients to be lost during the process, and that is why we give all of our dogs NuVet daily. NuVet Plus is cold processed, allowing all of the benefits of its rich nutrients to be retained, giving your new puppy an extra layer of protection, especially during the most critical first year of life. Rising Star Kennels is so confident NuVet Plus will benefit your new puppy; we will extend our health guarantee by 12 months. To qualify for this guarantee extension, you must give your new puppy NuVet Plus, using the manufacturer's recommended daily dosage, for the entire guarantee period (24 months from date of purchase). Failure to do so makes this guarantee extension null and void. We also highly recommend you continue to give your pet NuVet Plus beyond the guarantee period to promote optimal health for a lifetime. Please be sure to keep your records.

At no time will a refund of cash money be given. Seller must be provided with a written report of the dog's health problem from Buyer's veterinarian. The Buyer assumes full responsibility for costs and care during this time.

If this dog is fed Grain Free dog food without Allergy Testing and Vet directives this contract is null and void.

3. The Buyer shall maintain the puppy in good condition, including adherence to a regular immunization schedule, heartworm preventative, good diet, and a clean and safe environment. **If at any time the buyer is unable to care for the puppy it is to be returned to the seller. No refund will be given.**

4. The Buyer has read and understands the foregoing and agrees that all parts and portions therefore constitute a binding agreement. This contract constitutes the entire agreement of the parties hereto with respect to sale herein. Buyer assumes responsibility of this contract and agrees to pay any court fees if buyer fails to live up to

the agreements listed in this contract.

5. Buyer agrees to pick-up or Seller to arrange shipping by 8 weeks of age. If the buyer is unable to take the puppy at that time there will be a boarding fee of \$10.00 per day for a maximum of 2 weeks after which time the seller will put the puppy back up for sale.

If at any time in its life the puppy is to be sold or given away, the Buyer shall notify the Seller and give the Seller first option to obtain the puppy back.
